bank controls the payment transaction; Travelers does not access your account directly.

It's your choice

You can select the deduction date, any day between the 1st and 28th of the month*. Travelers does not go directly into your bank account. We send a transaction to your bank requesting they take the deduction from your account. An electronic funds transfer is then sent from your bank to Travelers.

** If the day you designate does not fall on a business day, Travelers will make the deduction the next business day.*



How to sign up

1. Log on to www.eft.travelers.com or visit your local Travelers agent to request an enrollment form.
2. Have your policy number(s), bank routing number, and savings or checking account numbers handy to complete the enrollment form.
3. Keep a copy of the enrollment form for your records and submit the original form to Travelers.
4. When the enrollment is complete, we will mail you a notice showing a schedule of deductions, including the amount and date when your payment will be deducted from your designated checking or savings account.

Electronic Funds Transfer is flexible

If you ever want to stop a deduction from occurring, notify Travelers within six business days of the scheduled deduction date. We will stop the deduction, and send you a paper bill. You also have the “right to revoke” the authorization for a specific deduction. To do this, call your bank to stop the deduction.
